Membership – currently Terms of Reference govern our group and as a member changes we should be renewing our Terms (re-enter the contract) vs incorporation no membership changes would require the same.3. Funding – currently we apply under umbrella of a non profit (Food Bank) and no additional reporting / taxes vs incorporation (with / without charitable status) would require funds, allows us to apply for funding independently. Noting that financial statements are required and we currently do not have these as we are under the Food Bank.4. Governance, Reporting & Accountability – we are informally meeting similar expectations placed on incorporated non profit and due to size no concerns vs increasing our reach / impact and funding requirements may require incorporation. <p>Discussion:</p> <p>Costs?
